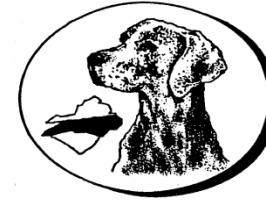

COURSE AND BIRDS:

Single course with bird field, using flight conditioned Bob White Quail

TESTS, RUNNING, AND STARTING TIMES:

Course A: Master Hunting Test – not before 7:30AM – 30 minutes
 Course A: Senior Hunting Test – to follow MH – 30 minutes
 Course B: Junior Hunting Test – not before 10:00AM – 15 minutes

ENTRY FEES:

Entry fees will not be returned for dogs withdrawn after closing, except for bitches in heat.
 Entry fees also will not be returned if a test has to be halted due to circumstances beyond the control of the club, eg lightning or inclement weather.

LIMITED ENTRY:

Entries limited to the number of dogs which may be run in daylight hours, and entries will close when the limit is reached if this occurs prior to the specified closing time. Entries not considered complete until payment is received.

PRIZES:

Orange 3-streamer Rosettes for qualifying dogs
 New Title ribbons for dogs finishing a title

DIRECTIONS TO THE TEST SITE:

From US-1 S in Sanford: Turn right onto US 15-S / US-501 S, and follow it for 17.3 miles. Turn right onto NC-73, and follow it for 7.5 miles. Turn left onto NC-211 / NC-73, and continue for .2 miles. Turn right onto NC-73 and continue for 4.5 miles. Turn right onto Jackson Springs Rd, and go for 1.3 miles. The grounds are on the right, 0.7 miles past Ivan Rd.

From US-220: Take the NC-73E exit, #16. Turn left onto NC-73E and continue for 6.5 miles. Turn left onto Jackson Springs Rd, and go for 1.3 miles. The grounds are on the right, 0.7 miles past Ivan Rd.

North Carolina law requires that everyone, age 16 and over, who attends this event have a hunting license (North Carolina or state of your residence) even if you don't carry a gun.

Lunch: *There are no eating establishments near the hunt test grounds. The club will arrange a catered lunch that can be purchased for \$7 each, or you can bring your own lunch. Please indicate if you want lunch with your entries and include payment. If there is enough, you will also be able to purchase on the grounds.*
